H. OLD BUSINESS

An Ordinance Amending the Animal and Zoning Chapters of the Village of Chatham Code of Ordinances will remain Old Business. A Public Hearing with the Planning Commission needs conducted before the village board can act on this ordinance.

Trustee Schatteman moved, seconded by Trustee Mau, to bring to the table **Ordinance 11-45, An Ordinance Approving Contracts with Springbrook Software Company.** Selected to provide the Village with financial and administrative software, 11-45 was approved by roll call vote 5 yes, 0 no, 1 absent as follows: Herr - yes, Mau - yes, Boyle - yes, Holden - yes, Kavanagh - absent, Schatteman - yes.

Trustee Schatteman moved, seconded by Trustee Mau, to bring to the table **Ordinance 11-46, An Ordinance Approving a Financing Transaction with Illinois National Bank.** In an amount not to exceed \$200,000 at an interest rate of 2% to finance the cost of the Springbrook Software, 11-46 was approved by roll call vote 5 yes, 0 no, 1 absent as follows: Herr - yes, Mau - yes, Boyle - yes, Holden - yes, Kavanagh - absent, Schatteman - yes.

Ordinance 11-48, An Ordinance Approving a Lease Purchase Agreement with Illinois National Bank. In an amount not to exceed \$78,000 at an interest rate of 2% to finance the acquisition of Police Vehicles, 11-48 was approved by roll call vote 5 yes, 1 no, 1 absent as follows: Herr - yes, Mau - no, Boyle - yes, Holden - yes, Kavanagh - absent, Schatteman - yes, Mayor Gray - yes. Trustee Herr moved, seconded by Trustee Boyle, to bring to the table Ordinance 11-49, An Ordinance Relating to No Parking Signs on Plummer Boulevard. Staff reviewed appropriate traffic manuals and recommended placing no parking signs on Plummer Boulevard from Peach Tree Drive to Gordan Drive. 11-49 was approved by roll call vote 4 yes, 1 no, 1 absent as follows: Herr - yes, Mau - no, Boyle - yes, Holden - yes, Kavanagh - absent, Schatteman - yes.

Trustee Schatteman moved, seconded by Trustee Mau, to bring to the table Resolution 37-11, A Resolution Appointing Members to the Village of Chatham Public Properties and Recreation Commission. Jason Aieman, Tim Anderson, Melinda Bentley, Amy Dickerson-Ferguson, Jay Hoffman, Jared Koester, Scott Kuntz, Ethan Manning, Michelle Marquess, Tim Mathis, Tom McQuire, Roland Saucier, Brent Stice, Shauna Trautvetter and Scott Wahbrink were appointed. 37-11 passed by roll call vote 5 yes, 0 no, 1 absent as follows: Herr - yes, Mau - yes, Boyle - yes, Holden - yes, Kavanagh - absent, Schatteman - yes.

Mayor Gray asked for a motion appointing Melinda Bentley Chairperson of the Public Property and Recreation Commission. Trustee Schatteman made that motion, seconded by Trustee Herr, the motion passed by roll call vote 5 yes, 0 no, 1 absent as follows: Herr - yes, Mau - yes, Boyle - yes, Holden - yes, Kavanagh - absent, Schatteman – yes.
