C. ROLL CALL

I. NEW BUSINESS

Trustee Kavanagh moved, seconded by Trustee Herr, to bring to the table Ordinance 12-11, An Ordinance Adding Recreational Class Liquor Licenses to be Issued by the Village of Chatham and Amending the Village of Chatham Code of Ordinances. This new liquor license accommodates Spartan Sports Park on Gordon Drive, east of Glenwood High

School, opening this spring. 12-11 passed by roll call vote 5 yes, 0 no, 1 absent as follows: Herr - yes, Mau - absent, Boyle - yes, Holden - yes, Kavanagh - yes and Schatteman - yes.

Trustee Kavanagh moved, seconded by Trustee Boyle, to bring to the table Ordinance 12-12, An Ordinance Enacting and Adopting a Supplement to the Code of Ordinances for the Village of Chatham. This ordinance approves the supplemental update to the Village of Chatham Code of Ordinances that was prepared by American Legal Publishing. 12-12 passed by roll call vote 5 yes, 0 no, 1 absent as follows: Herr - yes, Mau - absent, Boyle - yes, Holden - yes, Kavanagh - yes and Schatteman - yes.

Trustee Kavanagh moved, seconded by Trustee Herr, to bring to the table **Resolution 13-12, A Resolution Relating to Elected Officials in IMRF.** Elected officials may participate in Illinois Municipal Retirement Fund if they are in positions normally requiring an annual performance of duty for 600 hours or more. Because of the annual 600 hour requirement: the Village President and Village Clerk are qualified. Village Trustees elected after 1/1/2007 do not qualify. Further, this Resolution rescinds Resolution 93-22. 13-12 passed by roll call vote 5 yes, 0 no, 1 absent as follows: Herr - yes, Mau - absent, Boyle - yes, Holden - yes, Kavanagh - yes and Schatteman - yes.

Trustee Schatteman moved, seconded by Trustee Holden, to bring to the table **Resolution 14-12**, **A Resolution Granting the St. Andrew's Society of Central Illinois use of the Chatham Community Park.** Regarding the Societies May 17-20 Highland Games, 14-12 passed by roll call vote 5 yes, 0 no, 1 absent as follows: Herr - yes, Mau - absent, Boyle - yes, Holden - yes, Kavanagh - yes and Schatteman - yes.

Trustee Schatteman moved, seconded by Trustee Holden, to bring to the table **Resolution 15-12**, **A Resolution Granting the Chatham American Legion use of the Village Square.** Regarding the Legionnaire's June 21-23 Homecoming Festival, 15-12 passed by roll call vote 5 yes, 0 no, 1 absent as follows: Herr - yes, Mau - absent, Boyle - yes, Holden - yes, Kavanagh - yes and Schatteman - yes.
