

ORDINANCE NO. 66-5

AN ORDINANCE LEVYING AND ASSESSING TAXES
FOR ALL NECESSARY EXPENDITURES OF THE
VILLAGE OF CHATHAM, ILLINOIS FOR THE FIS-
CAL YEAR BEGINNING MAY 1, 1966 AND ENDING
THE 30th DAY OF APRIL, 1967.

Whereas, on the 21st day of July, A. D. 1966, there was passed by the Board of Trustees of the Village of Chatham, Illinois, an ordinance making appropriations for all necessary expenditures for the Village of Chatham, Illinois, for the fiscal year beginning May 1, 1966 and ending April 30, 1967, and upon said date the said Ordinance was duly signed and approved by the Mayor of said Village and recorded by the Village Clerk thereof, and thereafter on the 29th day of July, A. D. 1966, said Ordinance was duly published according to law, and which said Ordinance is in the words and figures as follows, to wit:

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE
VILLAGE OF CHATHAM, ILLINOIS:

SECTION I. That exclusive of any and all amounts hereinafter levied for the payment of the principal and interest upon the outstanding bonded indebtedness of said Village and exclusive also of any and all taxes authorized by acts which by their terms provided that such taxes shall be in addition to taxes for general purposes, the sum of Twenty-seven thousand three hundred ten and no/100 Dollars (\$27,310.00) is hereby levied and assessed for the fiscal year ending the 30th day of April, A. D. 1967, for general corporate purposes upon all property subject to taxation within said Village of Chatham, at the full, fair cash value, as the same is equalized and assessed by the Department of Revenue of the State of Illinois for State and County purposes, in the following amounts and for the particular objects and purposes hereinbefore specified in the aforesaid appropriation ordinance, and therein identified by corresponding appropriation numbers and items as follows:

A. For the current expenses and capital outlays of the Administrative Departments sum of Eight thousand seven hundred sixty dollars (\$8,760.00) is hereby levied and assessed for the several purposes specified in the said appropriation ordinance and therein identified by corresponding appropriation numbers and items as follows:

1. Salaries of Village Officers	\$ 3,000.00
2. Salary and expenses of City Clerk	500.00
3. Extra help salary	800.00
4. Salary of treasurer	360.00
5. Legal expenses	900.00
6. Maintenance and material to repair Village Hall and other buildings.	500.00
7. Equipment repair.	400.00
8. Auditing expenses.	300.00

B. For the current expenses and capital outlays of the Street Department the sum of Sixteen thousand dollars (\$16,000.00) is hereby levied and assessed for the several purposes specified in the said appropriation ordinance and therein identified by corresponding appropriation numbers and items as follows:

C. For the current expenses and capital outlays of the Police Department, the sum of Two thousand five hundred fifty dollars (\$2,550.00) is hereby levied and assessed for the several purposes specified in the said appropriation ordinance and therein identified by corresponding appropriation numbers and items as follows:

SECTION II. There is hereby levied and assessed for Road and Bridge Purposes for the fiscal year ending the 30th day of April, 1967, in addition to all other taxes authorized by law to be levied and collected within the Village of Chatham and in addition to the maximum of the taxes authorized by Section 1 of Article 16 of the Revised Cities and Villages Act, the sum of Twenty-five hundred dollars (\$2500.00) upon all property subject to taxation within the Village, at the full, fair cash value of the same as equalized and assessed by the Department of Revenue of the State of Illinois for State and County purposes.

SECTION III. The Village Clerk of said Village of Chatham shall file with the County Clerk and the County Treasurer of Sangamon County, and State of Illinois, a certified copy of the ordinance and said County Clerk shall ascertain the rate per centum which, upon the total

value of all property subject to taxation within said Village of Chatham, at the full, fair cash value as the same is assessed and equalized by the Department of Revenue of the State of Illinois, for State and County purposes for the current fiscal year, will produce the net amounts herein levied and ordered, certified, and he shall extend the tax upon the tax books of the Collector of State and County Taxes within said Village as provided by law.

SECTION IV. This Ordinance shall take effect and be in force within the time provided by law from and after its passage, signing, and recording.

SECTION V. All Ordinances and parts of Ordinances in conflict herewith are hereby repealed.
