

AN ORDINANCE APPROVING MATTERS
OF VARIOUS NATURE
IN THE VILLAGE OF CHATHAM,
ILLINOIS

WHEREAS, SOUTH SPRINGFIELD COMPANY, Inc., a Delaware corporation, has engaged in a subdivision known as Chatham Knolls, First Plat, in the Village of Chatham, Illinois, being generally located in and a part of the Northwest Quarter of Section 12, Township 14 North, Range 6 West of the Third Principal Meridian, in Sangamon County, Illinois, and in the course of the development of that subdivision has caused Donklebrook Road to be made according to the specifications of the Village of Chatham, Illinois,

NOW, THEREFORE, BE IT ORDAINED by the Village Board of the Village of Chatham, Illinois:

Section 1: That the developers of Chatham Knolls Subdivision, First Plat, being South Springfield Company, Inc., a Delaware corporation, having installed Donklebrook Road in Chatham Knolls Subdivision, First Plat in accordance with the specifications of the Village Board of Chatham, Illinois for acceptance of the maintenance of said Donklebrook Road, Chatham Knolls Subdivision, First Plat, by the Village of Chatham, Illinois.

Section 2: That the public interests will be served by accepting all that portion of Donklebrook Road, commencing at the intersection of Glenwood and Donklebrook (Lots 53 and 54 of Chatham Knolls, First Plat) and terminating at the intersection of Glenwood and Donklebrook (Lots 35 and 39 Chatham Knolls, First

PLAT), located in Chatham Knolls Subdivision First Plat, being a part of the Northwest Quarter of Section 12, Township 14 North, Range 6 West of the Third Principal Meridian, in the Village of Chatham, Illinois.

Section 11: That the Village of Chatham hereby accepts all that portion of Demaiobrook Road commencing at the intersection of Glenwood and Demaiobrook (Lots 5) and 5A of Chatham Knolls First Plat) and terminating at the intersection of Glenwood and Demaiobrook (Lots 5) and 5A of Chatham Knolls, First Plat), located in Chatham Knolls Subdivision First Plat, being a part of the Northwest Quarter of Section 12, Township 14 North, Range 6 West of the Third Principal Meridian, in the Village of Chatham, Illinois.

Section 4: A vote of Ayes and Nays shall be recorded upon this ordinance.

Section 5: This ordinance shall take effect within the time as provided by law from and after its passage.
