AN ORDINANCE ANNEXING TERRITORY
FOR HIGHWAY PURPOSES

WHEREAS, the Village of Chatham presently incorporates segments of County Highway #40; and

WHEREAS, the present municipal limits of the Village of Chatham extend in part to the center of said highway; and

WHEREAS, the Village of Chatham seeks to annex to the Village that territory used for highway purposes and which is contiguous to the Village and constitutes the remaining one-half of those parts of said highway which is described as follows:

Part of the East $\frac{1}{2}$, of Section 7, and part of the West $\frac{1}{2}$, of Section 8, Township 14 North, Range 5 West, of the 3rd Principal Meridian, Sangamon County, Illinois, being more particularly described as follows:

All that part of Walnut Road (Sangamon County Highway 40) Right-of-Way lying North of the centerline of said Highway; beginning at a point 1,074.61 feet East of the center of said Section 7; thence East along said centerline to a point 103 feet East of the West line of said Section 8. Said parcel containing 1.16 acres, more or less,

and

WHEREAS, none of the said property is presently and no part thereof is presently within any other municipality; and

WHEREAS, all of the said property is contiguous to the Village of Chatham; and

WHEREAS, written notice has been sent by Certified Mail to the Trustees of the Chatham Community Fire Protection District more than ten days prior to the date of enactment of

this Ordinance, pursuant to the provisions of Section 7-1-1 of the "Illinois Municipal Code", effective May 29, 1961, as amended (Ill. Rev. Stat., 1975, Ch. 24, par. 7-1-1) notifying the Trustees of said Fire Protection District of the filing of this Ordinance and the intention of the Board of Trustees of the Village of Chatham to annex the said territory to the Village; and

WHEREAS, pursuant to the provisions of Section 7-1-1 of the "Illinois Municipal Code", the new boundary of the Village of Chatham shall extend to the far side of any highway adjacent to the annexed territory;

THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Chatham, Illinois:

Section 1. That the territory described as follows:

Part of the East $\frac{1}{2}$, of Section 7, and part of the West $\frac{1}{2}$, of Section 8, Township 14 North, Range 5 West, of the 3rd Principal Meridian, Sangamon County, Illinois, being more particularly described as follows:

All that part of Walnut Road (Sangamon County Highway 40) Right-of-Way lying North of the centerline of said Highway; beginning at a point 1,074.61 feet East of the center of said Section 7; thence East along said centerline to a point 103 feet East of the West line of said Section 8. Said parcel containing 1.16 acres, more or less,

be and the same is hereby annexed to the Village of Chatham, Illinois.

Section 2. That the new corporate boundary of the Village of Chatham shall extend to the far side of any highway adjacent to the annexed territory.

Section 3. That the Clerk of the Village shall file within 90 days hereto with the Recorder of Deeds of Sangamon

County, Illinois, a certified copy of this Ordinance and an accurate map of the territory annexed.


