

ORDINANCE NO. 83-12

AN ORDINANCE AMENDING AGREEMENTS  
WITH THE SPRINGFIELD SANITARY DISTRICT

WHEREAS, by reason of a contract entered into on April 13, 1976, between The Springfield Sanitary District and the Village of Chatham it was agreed that certain charges for sewer service would be imposed by the Village upon its customers; and

WHEREAS, said contract was amended by agreement dated September 1, 1980, by reason of which amendment rates and charges for such service were revised; and

WHEREAS, the parties thereto have disputed the amounts which the Village was to have charged its customers pursuant to said contract and amendment; and

WHEREAS, The Springfield Sanitary District has offered to resolve and settle the dispute, and the District has agreed upon the amount of past user charges and payments therefor and of a method of charging and accounting for future user charges, and The Springfield Sanitary District has offered to memorialize said resolution and settlement; and

WHEREAS, it is necessary for the Village to accept or reject said offer of The Springfield Sanitary District to resolve and settle said dispute;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:

Section 1: That the Village enter into an amendatory contract with The Springfield Sanitary District again amending the contract of April 13, 1976, as amended by a contract dated September 1, 1980, said amendatory contract to include at least the following provisions:

- A. The Springfield Sanitary District (District) will accept all payments paid by the Village from February 1980, through September 15, 1980, as being correct and proper and no additional payments due for this period.
- B. The District will accept the information on the number of sewer users within the Village for each month from October 15, 1980, through December 15, 1982, as prepared by Clifford N. Keven as being correct and accurate.
- C. No additional amounts as stated in number 1 above are owed by the Village, which reduces the total for 1980, 1981

and 1982 from \$42,400.50 to a revised total of \$35,292.00. Further, this amount is to be reduced by \$1,414.75, which is overpayments for the first three months of 1983. The final revised amount owed through March 15, 1983, is \$33,877.25.

D. The Village will make payments to the District in addition to the amount owed each month which is \$0.1738 per 1000 gallons and \$0.75 for each sewer user, said payments to be made according to the following schedule:

E. The District will not require the Village to pay interest for the period when the money is owed (said interest amounting to more than \$5,000.00) if the above schedule is adhered to.

Section 2: This Ordinance shall be effective upon passage

and approval as provided by law.
