

ORDINANCE NO. 83- 28

AN ORDINANCE PROVIDING FOR THE ACCEPTANCE OF THE
DEDICATION OF SEWERS IN THE SECOND ADDITION TO COUNTRY
VALLEY SUBDIVISION

WHEREAS, J. A. Robinson & Associates, Inc. as owner of the sanitary sewerage collection system serving Lots Twenty-eight (28) through Thirty-four (34), inclusive of the Second Addition to Country Valley Subdivision, Chatham, Illinois, having heretofore dedicated to the Village of Chatham the sanitary sewerage collection system serving Lots Twenty-eight (28) through Thirty-four (34), inclusive of the Second Addition to Country Valley Subdivision, Chatham, Illinois; and

WHEREAS, J. A. Robinson & Associates, Inc. as owner heretofore on May 24, 1983, contracted with the Village of Chatham that J. A. Robinson & Associates, Inc. shall cause all such sewers to be televised and observed by the Village of Chatham, Illinois, as provided in said contract; and

WHEREAS, J. A. Robinson & Associates, Inc. has completed all the requirements of such contract to be performed by J. A. Robinson & Associates, Inc.;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:

Section 1: The Village of Chatham, Sangamon County, Illinois, does hereby accept dedication of the sanitary sewerage collection system serving Lots Twenty-eight (28) through Thirty-four (34), inclusive of the Second Addition to Country Valley Subdivision, Chatham, Illinois.

Section 2: The corporate authorities of the Village of Chatham, Sangamon County, Illinois, be and they hereby are authorized and directed to sign a document accepting the dedication of such sanitary sewerage collection system in the form and style of the document attached hereto.

Section 3: All ordinances, resolutions and parts thereof in conflict herewith be and the same hereby are repealed.


Section 4: This Ordinance shall be effective upon passage


WHEREAS, J. A. Robinson & Associates, Inc. has completed all the requirements of such contract to be performed by J. A. Robinson & Associates, Inc.;


