ORDINANCE ANNEXING CERTAIN DESCRIBED PROPERTY
TO THE VILLAGE OF CHATHAM

WHEREAS, ROBERT MAU AND DOROTHY MAU, of the County of Sangamon and State of Illinois, having filed their verified Annexation Petition duly executed and sworn, stating that the property described on Annex A attached hereto, incorporated herein and made a part hereof, is contiguous to the said Village of Chatham, Illinois; that no part thereof is included in the incorporated limits of any municipality; that said Petitioners are the sole owners of said property; that 100% of the electors residing upon or occupying the lands within the above-described annexed territory have joined in the Petition; and are requesting that said territory be annexed to the Village of Chatham, Illinois; that the property upon annexation will be classified under the Pre-urbanized Zoning District (P-I) of the 1982 Zoning Ordinance of the Village of Chatham, Illinois;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF CHATHAM, ILLINOIS:

SECTION I That the area within described be and the same is hereby annexed to the Village of Chatham, Illinois, and upon annexation shall be classified under the Pre-urbanized Zoning District of the 1982 Zoning Ordinance of the Village of Chatham, Illinois.

3) THAT the undersigned, ROBERT MAU AND DOROTHY MAU, of the County of Sangamon and State of Illinois are the true and correct owners of record of all the land within the above-described territory, as established by the records in the Office of the Recorder of Deeds of Sangamon County, Illinois, and that there are no other persons, firms, or corporations who have any right, title or interest of record in and to any land

within said above-described territory herein requested to be annexed.



5) THAT a plat of the real estate sought to be annexed prepared by a registered land surveyor is attached hereto.


