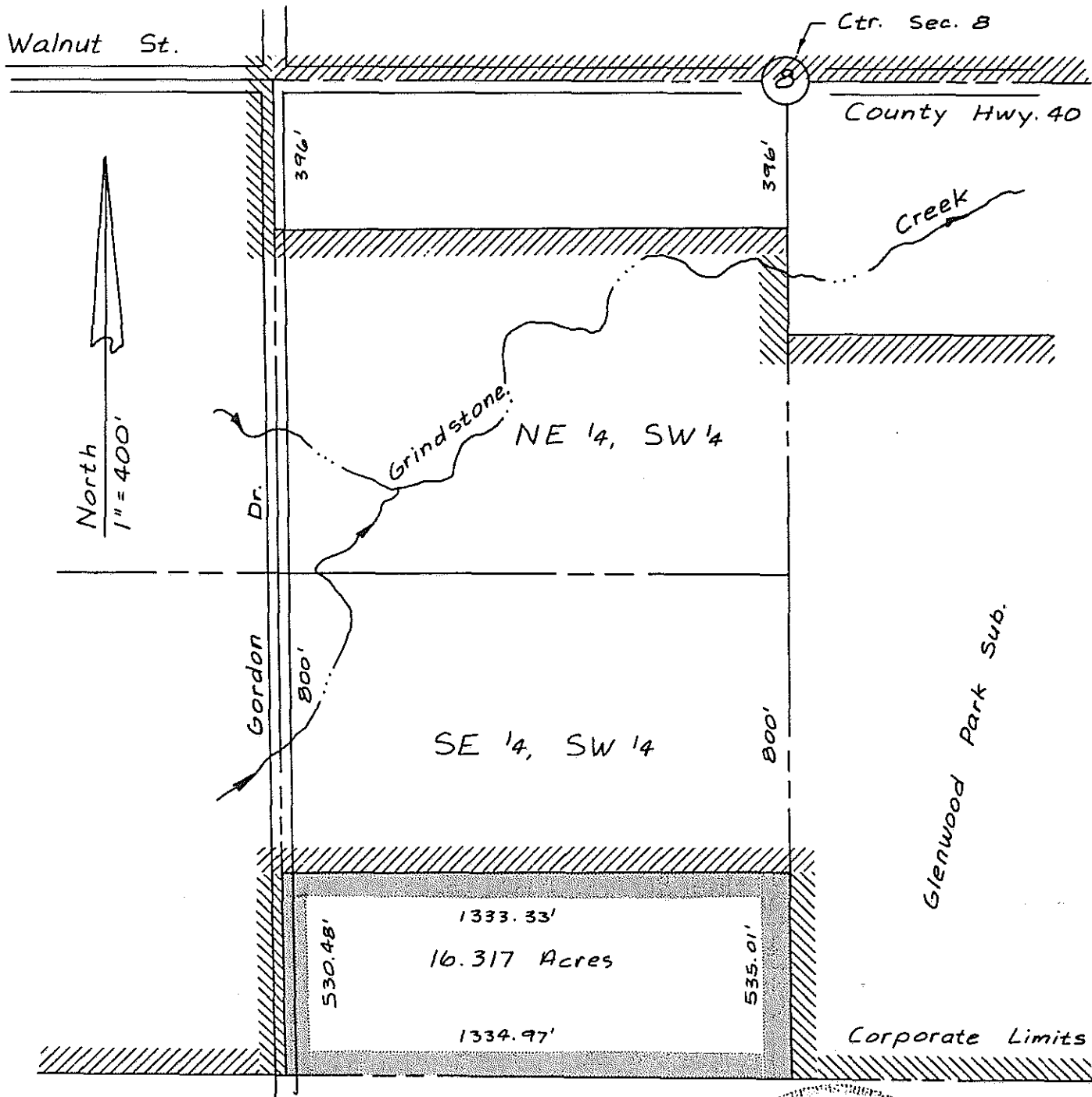

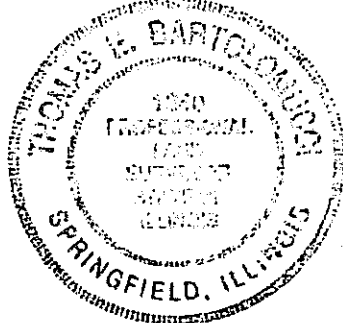
EXISTING CORPORATE LIMITS

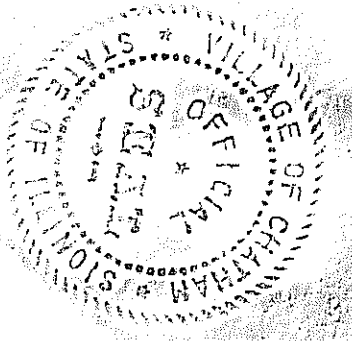

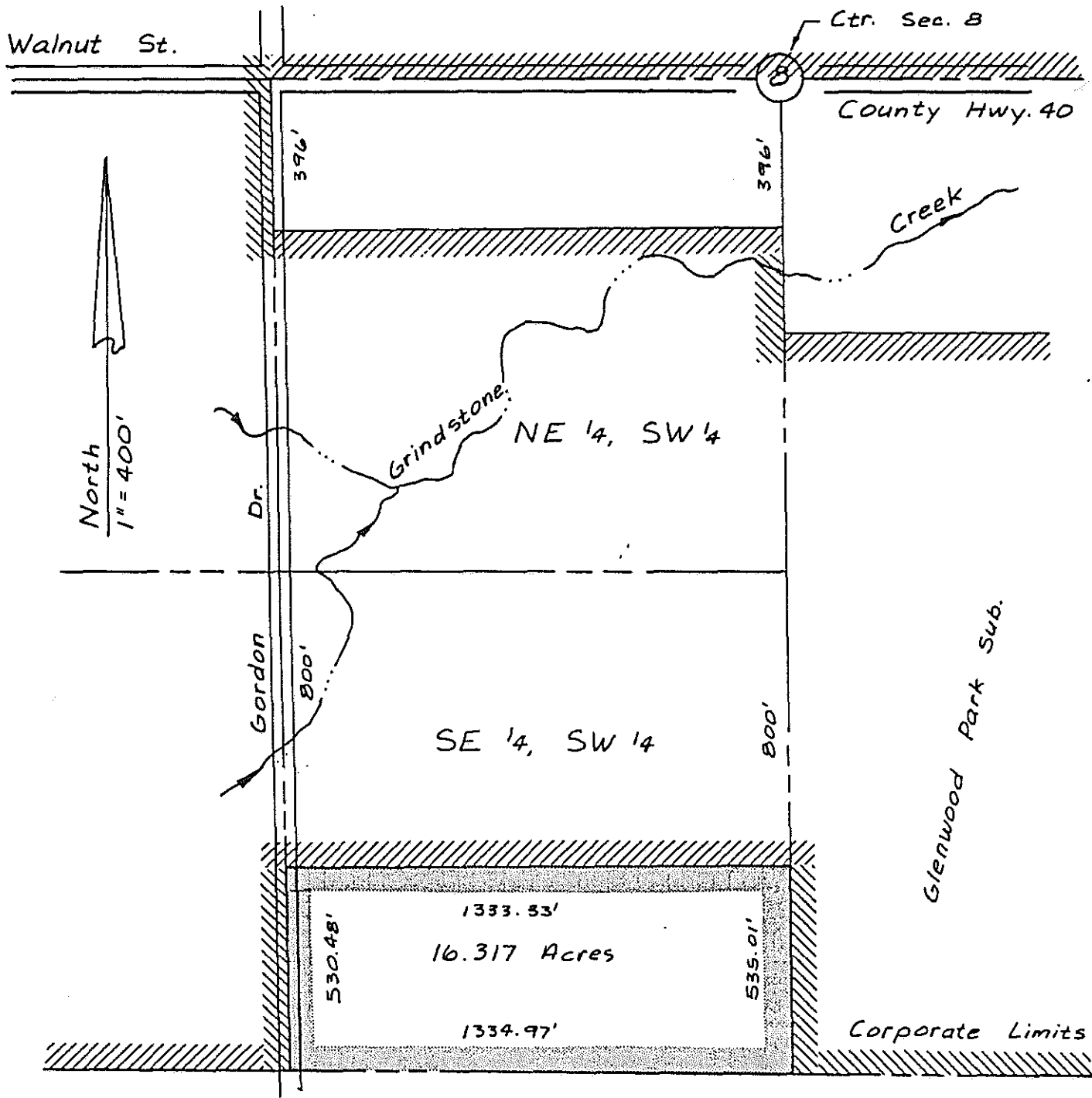

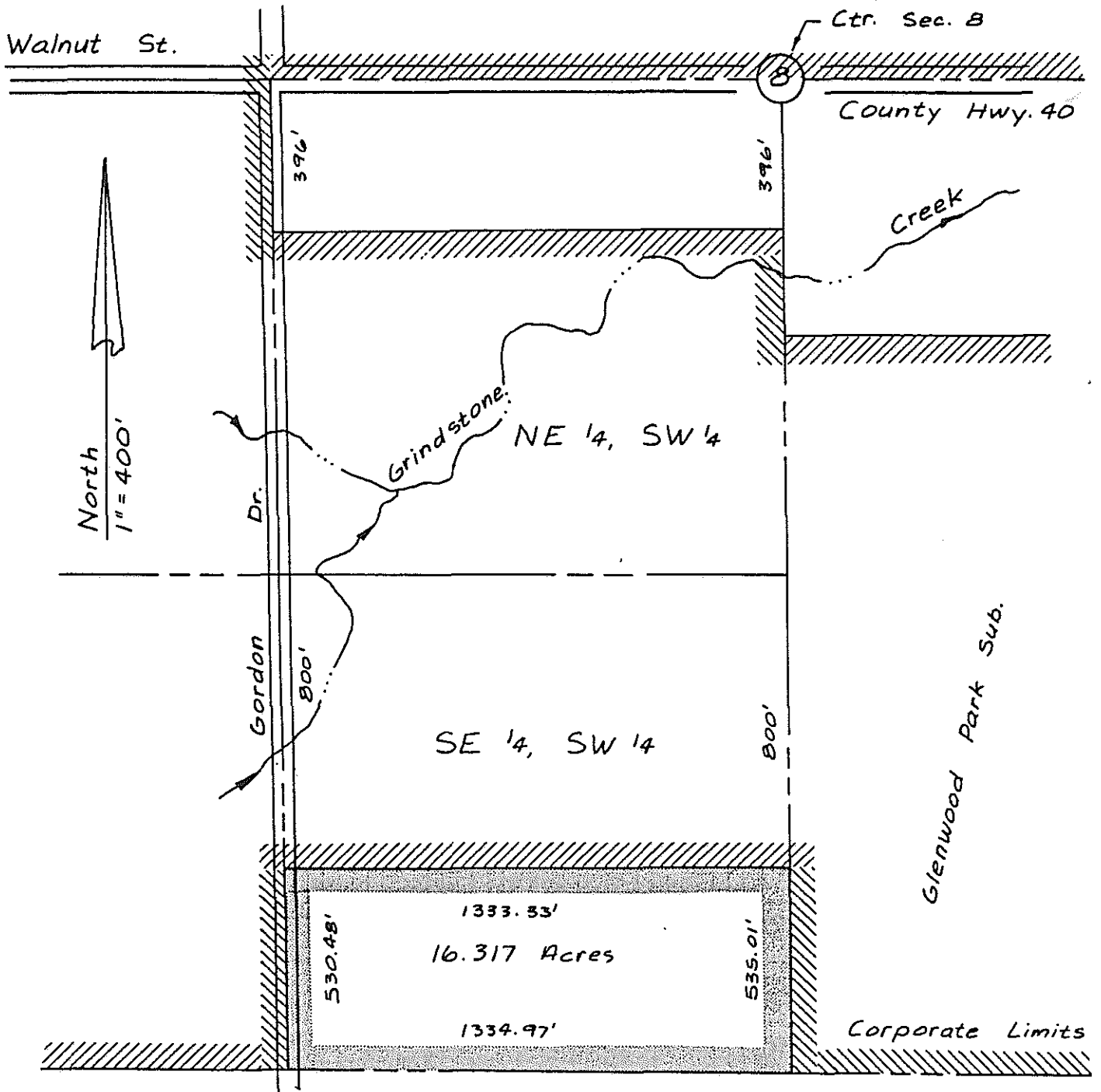
