

ORDINANCE NO. 89-45

ORDINANCE IN REFERENCE TO VILLAGE EMPLOYEES AND SALARIES

WHEREAS, the following named person is to be employed by the Village of Chatham at the salary rates dictated by contract provided; and

WHEREAS, by Ordinance No. 89-7, the Village established salaries for the village employees; and

WHEREAS, the manpower requirements for the Village of Chatham and the labor agreement between the Village of Chatham and Local Union No. 51 of the IBEW dictate a need;

NOW, THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS AS FOLLOWS:

Dear Mr. Moore:

During our negotiations in 1988 it was agreed to put Shane Hill at whatever wage rate that was negotiated for his classification in 1989. It was also agreeable that anyone who was hired after our new contract would be paid at the rate for the classification for which they were hired, including any negotiated increase.

In our conversation today we agreed to a 6% wage increase per classification. This will be effective May 1, 1989 through April 30, 1990 at which time a new contract would be negotiated.

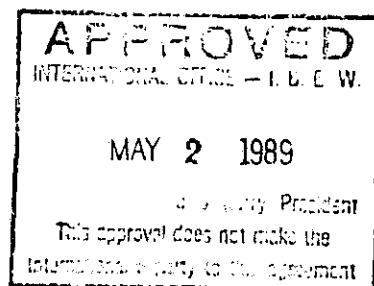
