

ORDINANCE NO. 90- 47

AN ORDINANCE APPROVING A CONTRACT WITH
SANKEY CONSTRUCTION, INC. AND WAIVING BIDS

WHEREAS, Sankey Brothers, Inc. has entered into a contract with the Developer of Prairie Grove Subdivision for construction of certain sewer improvements for the Subdivision;

WHEREAS, the Village of Chatham desires certain storm sewer improvements which are immediately contiguous to the improvements being constructed for Prairie Grove Subdivision;

WHEREAS, the corporate authorities have determined that if Sankey Brothers, Inc. performs the storm sewer improvements in conjunction with the improvements for Prairie Grove Subdivision, the storm sewer improvements can be quickly and expeditiously carried out;

WHEREAS, pursuant to Section 8-9-1 of the Illinois Municipal Code, a construction contract may be entered into without advertising for bids if authorized by vote of 2/3 of the trustees then holding office.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, ILLINOIS, AS FOLLOWS:

SECTION 1. A contract with Sankey Brothers, Inc. in the contract amount of \$30,095.00 for storm sewer improvements, a copy of which is attached hereto as Exhibit A, is hereby approved.

SECTION 2. The President and Clerk of the Village are hereby authorized and directed to execute and attest such contract on behalf of the Village, and the proper officers of the

Village are authorized and directed to perform the contract according to its terms.

SECTION 3. Bids are hereby waived for this storm sewer improvement project.

SECTION 4. This Ordinance shall be effective upon its passage by affirmative vote of 2/3 of the Trustees of the Village of Chatham then holding office.


