INVITATION TO BID

The Village of Chatham is requesting sealed bids in conformance with the requirements established by the Specifications:

BID OPENING DATE: NO bids will be considered after 1:00 p.m. Local Time, March 16, 1992, at which time all bids received will be publicly opened and read aloud. Bids must be addressed to Del McCord, Village Administrator 116 East Mulberry, Chatham, IL 62629.

SUBMISSION OF BIDS: A separate copy of the BID FORM, included with specifications, is bound together with the Invitation to Bid. The Bid Form must be filled in, executed by the bidder, and submitted in a sealed envelope which must be clearly marked: "MOWER BID PROPOSAL"

TAXES: Sales of any kind to Village and other governmental bodies, are exempt from the RETAILER'S OCCUPATION TAX, SERVICE USE TAX, and FEDERAL EXCISE TAX.

BID RESERVATIONS: Village of Chatham reserves the right to reject any or all bids, or any part thereof, to waive immaterial technicalities in the bidding and to accept the bid deemed most favorable to the interest of the Village after all bids have been examined and evaluated.

WARRANTY: The mower shall be covered by a warranty against defects in material, workmanship, and/or performance for a period of one year from the date of acceptance.

LITERATURE: Bidder shall submit one (1) set of literature describing the make and model of truck he proposes to furnish.

DELIVERY REQUIREMENTS: The bidder hereby agrees, if his bid is accepted, to deliver the specified mower to the Village of Chatham, at 116 East Mulberry, Chatham, IL. The bid price shall be a delivered price, i.e., F.O.B., to the Village, with all transportation and handling charges prepaid by the bidder.

SPECIFICATIONS FOR A TRACTOR WITH A
FRONT MOUNTED MOWER

REQUIREMENT OF THE BIDDER

All bidders shall quote upon a manufacturer's latest standard conventional model mower. The mower quoted shall be furnished complete with all standard features plus any optional or specialized parts required to meet the following specification. All parts not specifically mentioned, which are necessary to provide a complete unit, shall be included in the bid and shall conform in strength and quality of material and workmanship to what is usually provided to the trade in general.

Deviation from the specification requirements shall be specifically cited by the bidder and acceptance made on the basis of the exception. Efforts to obtain low bid prices by deviation from the listed specification will not be allowed! Failure to comply with the aforementioned provision will constitute grounds to reject the "Bid Proposal".

Bidders quoting on other than specified parts, equipment and options must submit, with their bid, written proof the proposed parts, equipment and options, equal or exceed, that which is specified in all respects including capacity, operating features and accessory items.

SAFETY COMPONENTS

The mower shall be furnished complete with all safety components that are required by the current Federal Safety standards for the size of mower proposed to be furnished.

MOWER INSPECTION

The proposed mower will be subject to an inspection for compliance with "Bid Specifications" at the time of delivery to the village. Items that are missing or do not meet "Bid Specification" requirements shall be corrected at the bidder's expense.

Before the mower is delivered to the Village, the successful bidder shall make a complete inspection of the equipment to insure the complete inspection of the equipment to insure the complete operation of the mower and that all parts are properly lubricated and adjusted. The bidder shall correct any defects before delivery.
