**AN ORDINANCE APPROVING A CONSULTING AGREEMENT**

AGREEMENT

THIS AGREEMENT is between the Global Learning Institute, Inc. ("GLI"), and the Village of Chatham, Illinois ("Village"), and is dated this 9 day of JUNE, 1992.

1. Global Learning Institute, Inc., agrees to provide certain consulting services to the Village of Chatham, including the following:

a. GLI will, through its Director, John T. Thompson, attend up to two strategic planning meetings of the Village Board, at which the Village Board will attempt to devise vision statements for use in the Village's ongoing long term planning process.

b. GLI will provide a written report based upon the board meetings.

c. GLI will present a written report to the Board.

2. GLI and the Village will agree on dates for the Village board meetings, but the parties anticipate that the work will be completed by September 1, 1992.

3. For its services, GLI shall be paid the sum of \$1200.00 upon completion of the work.
