**SECTION 1:** The Agreement between the Village of Chatham and Tonya Nantkes, attached hereto as Exhibit A is hereby approved.



AGREEMENT

THIS AGREEMENT is between Tonya Nantkes and the Village of Chatham, an Illinois municipal corporation, and is effective May 1, 1994.

1. Village of Chatham agrees to give Tonya Nantkes a non-exclusive right to sell food items and Pepsi-Cola beverages at the concession stand at the Chatham Community Park for the period May 1 through September 1, 1994.

2. Tonya Nantkes agrees to abide by all health and safety ordinances and regulations of the Village, County and State; to keep the concession stand clean and sanitary when in use and locked when not in use; and further agrees to indemnify the Village of Chatham from all claims and causes of action brought by any third party arising in whole or in part from the concession sales; and further assumes and will indemnify the Village against all premises liability, risks and claims associated with the concession stand.

3. This Agreement may be terminated by either party with or without cause on five (5) days notice.


