

Ordinance No. 94-39

AN ORDINANCE RETAINING LIN ENGINEERING, INC. ^{2fd}
FOR CERTAIN CONSULTING ENGINEERING WORK FOR THE VILLAGE

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE
VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: The engineering firm, Lin Engineering, Inc., ^{Ltd} is hereby retained as a consulting engineering firm for the Village of Chatham, to work on subdivision review projects as determined by the Village Administrator of the Village, or in the absence of the Village Administrator, by the Zoning Administrator of the Village.

SECTION 2: The work to be performed by Lin Engineering shall be performed pursuant to the terms and conditions contained in ^{"Agreement for Consultant Services"} an ~~in~~ schedule attached hereto as Exhibit A. ^{Ltd}

SECTION 3: The engagement of Lin Engineering, Inc. as a consulting engineer is terminable by either party at any time on written notice.

SECTION 4: This Ordinance is effective on its passage. To the extent that Lin Engineering has already performed work at the behest of the Village Administrator or Zoning Administrator prior to the date of passage of this Ordinance, the acts of the Village Administrator and the Zoning Administrator in requesting such consulting engineering work are hereby ratified, and Lin Engineering shall be paid in accordance with Exhibit A hereto for such work.

AGREEMENT FOR CONSULTANT SERVICES

This is an AGREEMENT between Village of Chatham, 116 East Mulberry, Chatham, Illinois 62629, hereinafter referred to as the "VILLAGE", and LIN Engineering, Ltd., 210 West Chestnut, Chatham, Illinois 62629, hereinafter referred to as the "CONSULTANT".

The VILLAGE proposes to engage the CONSULTANT to furnish certain professional services in connection with the engineering plan review. The proposed plan review involves engineering drawings for the development of the subdivisions in Chatham, which work is hereinafter referred to as the "PROJECT".

The VILLAGE has authority to engage such services, and the CONSULTANT represents that he/she is in compliance with Illinois Statutes relating to professional registration of individuals and to corporate practice, if a corporation, for rendering such services.

The CONSULTANT, in signing this AGREEMENT, certifies that he/she has no financial or other interests in the outcome of this project.

Under penalties of perjury, the CONSULTANT certifies that 37-1274976 is their correct Federal Taxpayer Identification Number and they are doing business as a Corporation.

In consideration of these premises, the parties hereto agree as set forth in the following page.

EXHIBIT A

1.0 The parties hereby certify that there was compliance with the provisions of the 1994 Land Subdivision Ordinance of the Village of Chatham and the State of Illinois's Architectural, engineering and Land Surveying Qualifications Based Selection Act, Chapter 30 ILCS 53.5/1 et seq., in the procurement of the services covered by this Agreement.

2.0 Scope of Work - The CONSULTANT shall complete the following work on the PROJECT.

Engineering services are required for the Plan Review of the

- a) Location and Sketch Maps
- b) Preliminary Plan
- c) Construction Plan
- d) Construction and Bonding of Public Improvements
- e) Final Plat
- f) Design Standards and Specifications
- g) Construction Inspection

3.0 Project Schedule - The CONSULTANT shall commence work within 2 Calendar Days after date of Authority to Proceed. CONSULTANT shall complete the Plan Review and deliver to the VILLAGE in accordance with the 1994 Land Subdivision Ordinance of the Village of Chatham.

4.0 Prime Compensation - The VILLAGE agrees to pay the CONSULTANT for the Work specified in the AGREEMENT at the specific hourly rates of pay based upon a provisional overhead and fringe benefit rate specified below for each class of employee as listed below for the actual time the CONSULTANT directly utilizes each such employee on the Work plus the CONSULTANT'S actual expenses for transportation and subsistence to the Work.
