Ordinance No. 94-40

AN ORDINANCE RELATING TO STOP SIGNS

WHEREAS, pursuant to Section 11-304 and other sections of the Illinois Vehicle Code, local authorities are required to place and maintain such traffic control devices upon highways under their maintenance jurisdiction as are required in their discretion to indicate and carry out the provisions of the Illinois Vehicular Code;

WHEREAS, pursuant to Section 11-305 and other sections of the Illinois Vehicular Code, the driver of any vehicle shall obey the instructions of any official traffic control device;

WHEREAS, the corporate authorities of the Village of Chatham, having conducted a stop sign inventory of the Village and having determined the necessity of additional stop signs not presently erected, wishes to designate all existing and new stop intersections in the Village.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: The vehicular intersections designated in Exhibit A to this Ordinance are hereby designated, pursuant to Section 11-304 of the Illinois Vehicular Code, as locations at which stop signs shall be placed and maintained by the Police Department.

SECTION 2: This Ordinance shall take effect upon its passage and publication as provided by law. The Clerk shall forthwith publish this Ordinance in pamphlet form.

SECTION 3: This Ordinance may be amended from time to time by adoption of an Ordinance amending Exhibit A hereto.


SECTION 4: Whenever territory containing stop signs is annexed, or whenever pursuant to construction plans approved by the Village in connection with its subdivision process, such stop signs shall be deemed to have been placed or held by the official act or direction of lawful authority in conformance with Section 11-305 of the Illinois Vehicular Code, without formal amendment of Exhibit A hereto by the corporate authorities of the Village.

SECTION 5: Ordinance No. 76-4, pertaining to stop signs is repealed.
