

Ordinance No. 94- 41

**AN ORDINANCE APPROVING A BID AND CONTRACT  
FOR WORK ON THE VILLAGE OF CHATHAM PUMP STATION**

WHEREAS, the Village of Chatham, by its consulting engineer, Hymans Engineering, Inc., let bids for water pump station electrical rehabilitation and installation of new telemetering monitoring and control systems, all in accordance with that document entitled "Contract Documents and Specifications, Village of Chatham Water System Improvements, Chatham, Illinois, May, 1994", prepared by Hymans Engineering (the "Contract Documents").

WHEREAS, the bids were opened on July 1, 1994, and Hymans Engineering has recommended acceptance of the low bid, that of Progressive Electric, for the base bid plus Alternative No. 1 in the total amount of \$129,467.00.

*NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:*

**SECTION 1:** The bid of Progressive Electric in the amount of \$129,467.00 is hereby accepted.

**SECTION 2:** The Village President is authorized and directed to execute on behalf of the Village of Chatham the contract contained in Contract Documents, and the proper officers of the Village are authorized and directed to carry out said contract according to its terms.

**SECTION 3:** This Ordinance is effective immediately.
