

Ordinance No. 94-62

**AN ORDINANCE APPROVING THE  
VILLAGE OF CHATHAM COMPREHENSIVE PLAN**

WHEREAS, the Village of Chatham Planning Commission, with the assistance of the Planning and Economic Development Committee of the Village Board and the Springfield Sangamon County Regional Planning Commission and Greene & Bradford, Inc., has drafted a new Comprehensive Plan for the Village of Chatham, Illinois.

WHEREAS, on June 8, 1994, after publishing a notice in the Chatham Clarion, a newspaper of general circulation within the Village of Chatham, the Village of Chatham Planning Commission held a public hearing regarding the proposed Comprehensive Plan and heard comments thereon from the public.

WHEREAS, on August 25, 1994, the Village of Chatham Planning Commission approved the Village of Chatham Comprehensive Plan and forwarded the plan for consideration by the corporate authorities of the Village of Chatham, Illinois.

WHEREAS, the new Comprehensive Plan has been reviewed and recommended for approval by the Planning and Economic Development Committee of the Board of Trustees of the Village.

WHEREAS, the corporate authorities of the Village of Chatham concur with the recommendations of the Planning Commission and the Planning and Economic Development Committee.


**NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:**

**SECTION 1:** The Comprehensive Plan for the Village of Chatham, Illinois dated October is hereby approved and shall be henceforth regarded as the official Comprehensive Plan of the Village, and shall be the document upon which planning activities in the Village of Chatham shall be based..

**SECTION 2:** The new Comprehensive Plan supersedes all previous comprehensive plans.


**SECTION 3:** This Ordinance is effective immediately.
