ORDINANCE 95-36

AN ORDINANCE IN REFERENCE TO SALARIES OF VILLAGE EMPLOYEES

WHEREAS, the following named persons are to be employed by the Village of Chatham at the salary rates herein provided.

NOW, THEREFORE, be it ordained by the President and Board of Trustees of the Village of Chatham, Sangamon County, Illinois, as follows:

SECTION 2: That the compensation rates set forth in Section 1 of this Ordinance may be superseded by compensation rates set in any valid collective bargaining agreement between the Village and a group of persons employed by the Village or by any valid contractual agreement between the Village and a person employed by the Village.

SECTION 3: That there shall be \$750 from the Electric Fund, \$750 from the Water Fund, and \$500 from the General Fund to be used for Annual Bonus purposes, with the specific employee amount to be determined by the Administrative Committee.

SECTION 4: That if any section, subsection, or sentence of this Ordinance shall for any reason be held invalid or to be unconstitutional, such decision shall not affect the validity of the remaining portion of this Ordinance.

SECTION 5: That this Ordinance shall be in full force and effect after its adoption and shall be retroactive to May 1, 1995.




