AN ORDINANCE RELATING TO STOP SIGNS

**WHEREAS**, pursuant to Section 11-304 and other sections of the Illinois Vehicle Code, local authorities are required to place and maintain such traffic control devices upon highways under their maintenance jurisdiction as are required in their discretion to indicate and carry out the provisions of the Illinois Vehicular Code;

**WHEREAS**, pursuant to Section 11-305 and other sections of the Illinois Vehicular Code, the driver of any vehicle shall obey the instructions of any official traffic control device;


**WHEREAS**, the corporate authorities of the Village of Chatham, through the Public Works Committee, has determined the necessity of additional stop signs not presently erected, wishes to designate new stop intersections in the Village.

NOW THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:


**SECTION 1:** The vehicular intersections designated in Exhibit A to this Ordinance are hereby designated, pursuant to Section 11-304 of the Illinois Vehicular Code, as locations at which stop signs shall be placed and maintained by the Village:

**SECTION 2:** This Ordinance shall take effect upon its passage and publication as provided by law. The Clerk shall forthwith publish this Ordinance in pamphlet form.


