Ordinance No. 97- 49

**AN ORDINANCE VACATING AN ALLEY
IN THE VILLAGE OF CHATHAM, ILLINOIS**

*BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE
VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:*

SECTION 1: Pursuant to Section 11-91-1 of the Illinois Municipal Code, 65 ILCS 5/11-91-1, the Village of Chatham hereby vacates that certain alley legally described on the Plat of Vacation attached hereto as Exhibit A.

SECTION 2: As required by Section 11-91-1 of the Illinois Municipal Code, the corporate authorities of the Village of Chatham hereby determine that the public interest will be subserved by the vacation of this alley.

SECTION 3: This vacation of alley is expressly subject to the reservation of an easement for the maintenance, renewal, construction and reconstruction of any and all Village and public utilities, including but not limited to gas, water, sewer and storm sewer utilities, presently within the vacated alley, or which the Village may wish to construct or to

to grant a franchise for in the future, said easement to consist of a 15 foot strip centered on any utility line existing or to be constructed by the Village or a public utility..

SECTION 4: The Clerk shall cause a true and correct copy of this Ordinance to be filed with the Recorder of Deeds of Sangamon County, Illinois.


SECTION 5: This Ordinance is effective immediately.

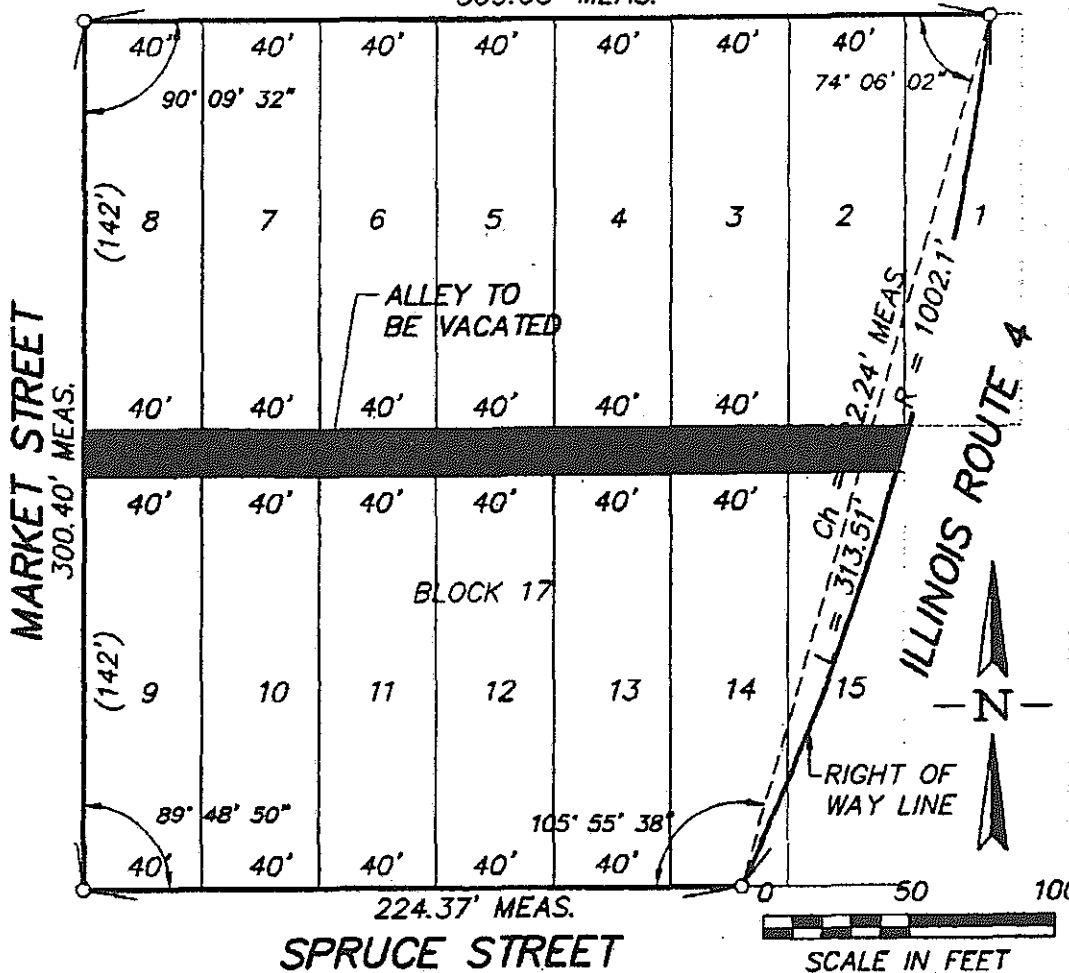


