
WHEREAS, pending the passage of such annual appropriation ordinance, the corporate authorities of the Village of Chatham have authority to and may make any necessary expenditures upon the basis of appropriations of the preceding fiscal year, as provided in Section 8-1-7 of the Illinois Municipal Code.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: Pending the passage of the annual appropriation ordinance for fiscal year May 1, 1998 through April 30, 1999, heads of departments or other agencies of the Village are hereby authorized, beginning May 1, 1998, to make necessary expenditures for the support thereof upon the basis of the appropriation of the preceding fiscal year.

SECTION 2: This Ordinance is effective immediately upon passage and approval.
