TERMS

- B. A Certificate of Insurance, which includes vehicles, equipment, general liability and Worker's Compensation coverage, will be furnished upon request.
- C. Ron Mason Lawn Care, Inc. will provide phone and pager numbers for access at all times.
- D. This mowing proposal will include mowing of all of the two cemetery sites when the grass reaches a height 3" or more. Weed eating around all grave stones at the two cemeteries will be provided at each mowing.
- E. Ron Mason Lawn Care, Inc. will not subcontract any part of this proposal.
- F. Ron or Britt will personally inspect these sites and will be available to the person overseeing these areas.
- G. All Ron Mason Lawn Care personnel will be dressed in company attire when providing services at these sites.

PROPOSAL PRICE

The cost for the above services for the proposal period of April 15, 2000 through October 31, 2000 will be divided into 7 monthly payments of \$ 1,200.00 each, for a total of \$8,400.00. The first billing will be April 15, with payment due within 28 days. Each additional billing for the next 6 months will be under these same terms.
