**AN ORDINANCE FIXING RATES AND CHARGES
FOR WATER FURNISHED BY THE WATERWORKS SYSTEM OF THE
VILLAGE OF CHATHAM, ILLINOIS AND
AMENDING THE VILLAGE OF CHATHAM CODE OF ORDINANCES**

*BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE
VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:*

SECTION 1: Section 51.018 (A) (1) of the Code of Ordinances of the Village of Chatham is amended to state as follows:

(A)(1) The following shall be the rates for water supplied through the waterworks system of the Village, payable monthly within 15 days after rendition of each bill.

<u>Volume</u>	<u>Inside Village Limits</u>	<u>Outside Village Limits</u>
Minimum 0-2,000 gal/month	\$10.20	\$13.40
All Over 2,000 gal/month	\$3.60 per 1,000 gal.	\$5.25 per 1,000 gal.


SECTION 2: This Ordinance shall take effect with respect to bills due on or after June 1, 2000. The Clerk shall forthwith publish this Ordinance in pamphlet form, and shall see to its inclusion in the next annual update of the Village of Chatham Code of Ordinances.
