ORDINANCE NO. 00-61

AN ORDINANCE PERTAINING TO VILLAGE EMPLOYMENT

**WHEREAS**, the Village advertised, accepted applications and interviewed for the positions of Grounds Maintainer, Water/Sewer Systems Maintainer; and

**WHEREAS**, the Village and the International Union of Operating Engineers negotiated, per the contract, and reached agreement for the starting salary of Grounds Maintainer and Water/Sewer Systems Maintainer to equal 80% of the current Water/Sewer systems Maintainer and Streets Maintainer, increase to 85% of current in year two, 90% of current in year three, 95% of current in year four, and 100% of current in year five; and

**WHEREAS**, the Administrative Committee has reviewed the staff recommendations and is affirmatively recommending the following persons for full-time Village employment:

Grounds Maintainer	-	Robert Isenhour
Grounds Maintainer	-	Ryan Crawford
Water/Sewer Systems Maintainer	-	Joseph Bickhaus

**NOW THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS AS FOLLOWS:**

**Section 1:** The following named persons shall be employed by the Village on a full time basis. Paid at an hourly rate and fund distributed as follows:

Robert Isenhour	\$10.823	100% Gen / 80% Prop 20% Streets
Ryan Crawford	\$10.823	100% Gen / 80% Prop 20% Streets
Joseph Bickhaus	\$10.823	90% W&S, 10% Gen / 10% Prop

In compliance with the Agreement between the International Union of

Operating Engineers and the Village of Chatham there will be a 120 day probation period. Date of employment shall be determined by the Administrator.

Section 2: This Ordinance shall be in full force and effect upon passage and approval.
