*AN ORDINANCE PERTAINING TO EMPLOYEE SALARIES*

**WHEREAS**, the Village advertised, accepted applications and interviewed for the position of CADD/GIS Technician; and

**WHEREAS**, the Village and the International Union of Operating Engineers negotiated, per the contract, and reached agreement for the salary of was reached on the CADD/GIS Technician to be equal to the current Maintainer positions of the current contract. Further, agreement was reached that the Lead Worker in Public Properties would be increased to 90% of the next highest Lead Worker in year one, 95% in year two, and 100% in year three of the current contract to balance the Village’s pay scale by the end of the current contract. The International Union of Operating Engineers will author an “Memorandum of Understanding” which will be executed by both parties to finalize contract clarifications; and

**WHEREAS**, the Village negotiating team and the International Union of Operating Engineers agreed during contract negotiations to review the salary of Arick Hansen and Charles Erickson at a latter date: and


**WHEREAS**, the Administrative Committee has reviewed the staff recommendations and is affirmatively recommending the salary adjustment of Arick Hansen and Charles Erickson.

***NOW THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS AS FOLLOWS:***

**Section 1:** The following named persons shall be paid the hourly rate negotiated with the International Union of Operating Engineers:
