
AN ORDINANCE FIXING THE REGULAR MEETING

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE
VILLAGE OF CHATHAM, ILLINOIS, AS FOLLOWS:

SECTION 1: That the Regular Meeting of the Board of Trustees of the Village of Chatham for the calendar year 2001 shall be held at the hour of 6:30 p.m. at the Village Hall located at 117 East Mulberry Street, Chatham, Illinois on the second and fourth Tuesday of each month except in February or April when the second or fourth Tuesday falls on election day and in December, when it shall be on the third Tuesday.
