

Ordinance No. 01- 21

**AN ORDINANCE APPROVING AN AGREEMENT
WITH BALL-CHATHAM COMMUNITY SCHOOL DISTRICT NO. 5**

*BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE
VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:*

SECTION 1: That certain agreement by and between the Village of Chatham, Illinois and Ball-Chatham Community School District No.5 pertaining to construction of improvements on Plummer Boulevard, a copy of which is attached hereto, is hereby approved.

SECTION 2: The Village President is authorized and directed to execute the Agreement on behalf of the Village, and the proper officers of the Village are authorized and directed to carry out the Agreement according to its terms upon its adoption by the School District.

SECTION 3: This Ordinance is effective immediately.

AGREEMENT

This agreement is between the Village of Chatham, Illinois ("Village") and Ball-Chatham Community School District No.5 ("District").

WHEREAS, the parties have had discussions relating to the funding of certain public improvements as set forth in an annexation agreement between the parties relating to the new high school;

WHEREAS, the parties have reached an accord regarding the issue of funding;

NOW, THEREFORE, THE PARTIES AGREE AS FOLLOWS:

1. The Village will enter into a contract with Freesen, Inc., to construct the signalization at Peachtree and Plummer Boulevard, and the asphaltting of Plummer Boulevard, during the calendar year 2001.

2. The District will pay the Village the sum of \$58,000 toward the Freesen contract, as follows: one-half on or before June 1, 2001; and the other half upon completion of the construction.




