

**AN ORDINANCE MAKING SUPPLEMENTAL APPROPRIATIONS

WHEREAS, on July 24, 2001, the President and Board of Trustees of the Village of Chatham adopted Ordinance No. 01- 47, the annual appropriation ordinance, for the fiscal year beginning May 1, 2001 and ending April 30, 2002;

WHEREAS, pursuant to Section 8-2-7 of the Illinois Municipal Code, the corporate authorities may at any time by a vote of two-thirds adopt a supplemental appropriation ordinance appropriating funds, the receipt of which were not anticipated at the time the balances available when the annual appropriation was adopted; and pursuant to Section 8-2-7, the provisions applicable to an initial appropriation ordinance relating to publication, notice and public hearing are not applicable;

WHEREAS, since passing the appropriation ordinance, the Village of Chatham has received funds to defray expenses connected with the Chatham Veterans Memorial, and wishes to appropriate such funds for expenditure in the current fiscal year;

*NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:*

**SECTION 1:** In addition to the amounts appropriated pursuant to Ordinance No. 01-47, there are hereby supplementally appropriated the following amounts, for the purposes indicated:

VETERANS MEMORIAL FUND

For Office Expenses	\$100
Materials and labor for construction of memorial	<u>9,000</u>
TOTAL	\$10,000

**SECTION 2:** This Ordinance is effective immediately. It shall be published by the clerk forthwith in pamphlet form.
