ORDINANCE 02 - 07

AN ORDINANCE IN REFERENCE TO VILLAGE EMPLOYMENT

**WHEREAS**, the Police Department posted a position of Dispatcher on the department bulletin board and advertised the position in the Chatham Clarion; and

**WHEREAS**, the Police Department conducted interviews of potential candidates and is recommending the appointment of Robert Willeford as the preferred candidate.

**WHEREAS**, a current employee, Randy Boston has given a letter of resignation.

**BE IT ORDAINED**, by the President and Board of Trustees of the Village of Chatham, Sangamon County, Illinois, as follows:

**SECTION 1:** Robert Willeford shall be employed as a Dispatcher on a full time basis to be paid per the current Union Contract distributed from the Electric, General and Water funds.

**SECTION 2:** This Ordinance shall be in full force and effect upon passage and approval.
