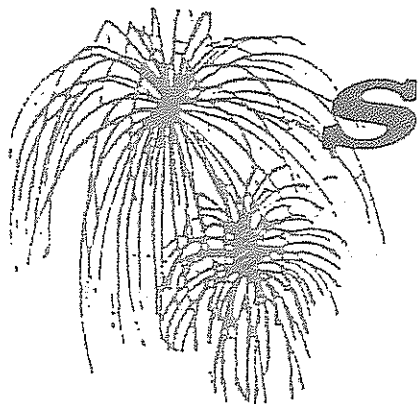

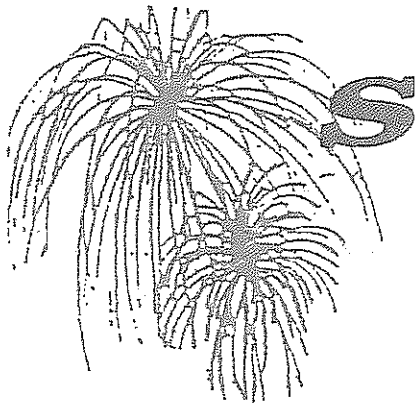

Dear Del:

Thank you, for using Central States these past few years for Chatham's fireworks needs. After we discussed the State of Illinois' storage and use policies, you indicated the best option for Chatham was to add liability coverage. In order to help Chatham with this added expense, I will extend our \$10,000,000.00 coverage to Chatham for \$350.

Attached is the paperwork for Chatham's 2002 fireworks display. It includes the proposal, an Agreement, a Liability Extension Questionnaire and a Permit.

The proposal contains the same amounts of pyrotechnics as 2001. I have changed some cakes and will mix in new effect shells to add variety. I have also added an additional cake in the finale. I felt I should do this because of the inconvenience of our being late on delivery last year.

The Agreement is our contract for the display. The Liability Extension Questionnaire gives us the information we need to obtain liability coverage. Please fill in the areas I have highlighted and return it with your order. The Questionnaire requires a drawing of the site with distances to exposed risks identified. We will also need a list of those handling the fireworks for our workers comp requirements. The list should include name, address and Social Security Number. I will talk with the Fire Chief concerning these two aspects. The Permit is the same we have used in the past.

As in past years, we will deliver the display on the morning of July 4<sup>th</sup> and return them to our magazine if there is a cancellation of the display for weather or other reason. Simply call me and we will arrange to put the fireworks in our storage.


