ORDINANCE NO. 03-04

AN ORDINANCE RELATING TO STOP SIGNS ON PARTRIDGE DRIVE AND CHUKAR DIRVE AT MALLARD DRIVE

WHEREAS, pursuant to Section 11-304 and other sections of the Illinois Vehicle Code, local authorities are required to place and maintain such trafffic control devices upon highways under their maintenance jurisdiction as are required in their discretion to indicate and carry out the provisions of the Illinois Vehicular Code: and

WHEREAS, pursuant to Section 11-305 and other sections of the Illinois Vehicular Code, the driver of any vehicle shall obey the instructions of any official traffic control device; and

WHERAS, Staff have reviewed the appropriate traffic manuals and is recommending the placement of stop signs on Mulberry Street at East Street and the removal of stop signs on Mulberry Street at East Street. The closing of the rail crossing on Mulberry Street changes the flow of traffic in the area.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: Chapter 71, Schedule I of the Village Code of Ordinances is amended by the addition of the following:

Street Which StopsDirection of TravelStop at Entrance ToChukar DriveNorth and SouthMallard DrivePartridge DriveNorth and SouthMallard Drive

SECTION 2 This ordinance shall take effect upon its passage and approval as provided by law. The Clerk shall forthwith publish this ordinance in the next update of the Village Code of Ordinances.
