AN ORDINANCE APPROVING THE PURCHASE OF A STREET SWEEPER

WHEREAS, the Village of Chatham sought and obtained bids for the purchase of one used/demo Street Sweeper; and

WHEREAS, the Village shall appropriate sufficient funds in the annual Appropriation Ordinance to purchase the equipment bid in the Motor Fuel Tax Fund, and

WHEREAS, on March 31, 2003, at 1:00 p.m. the attached bid was opened and the lowest responsible bidder identified; and

WHEREAS, the Village staff has reviewed the bid and is recommending acceptance of the lowest bid from Woody's Municipal Supply Inc. for the amount of \$61,585.00.

MECHANICAL STREET SWEEPER**

1. Model year 2000 or newer, max. 1000 hrs.
2. Must be a Demo unit with service records
3. Three wheel type, front wheel steer
4. Hydrostatic drive
5. High dump hopper, min. 5.0 cubic yard hopper capacity
6. Must have dual gutter brooms
7. Water tank must be of poly material
8. Must have a Upfront cab
9. Cab must have AC, Heat and Defroster
10. Engine must be min. 4cyl. Turbo-charged diesel
11. Engine must be water cooled
12. Elevator speed shall be variable and reversible
13. Pick-up broom shall be min. 56 in. long and 30 in. diameter
14. Pick-up broom shall be hydraulic with variable speed
15. Gutter brooms shall be min. 45 in. diameter
16. Gutter brooms must be hydraulic driven
17. Unit must be delivered with parts and service manuals
18. Deviations from specifications must be listed on Bid Form
