Section 2: That the appropriate officials be and are hereby directed to sign the necessary forms and documents.

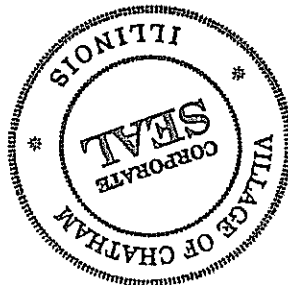
Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as provided by law.
