After review of your invitation to bid, Waste Management proposes to provide not less than five (5) 30 cubic yard roll off containers to the specified location and replace loaded containers with empty equipment for the duration of the event. All equipment will be removed at the end of the specified time of the event.

Our charge for the above outlined service, including transportation charges and disposal charges for the contents of the container will be \$ 235.00 per loaded container.

Ladies and Gentlemen:

Thank you, for the opportunity to provide you with this proposal.

- 1. "Flat Rate/Container" includes delivery, transportation, and disposal \$230.00 per 20yd for trash, \$255.00 per 25yd for trash, \$280.00 per 30yd container for trash, \$100.00 per container of any size for appliances, and \$600.00/rearload compactor truck for compactable items only.
- 2. "Transportation and Disposal" is \$110.00 transportation per container of any size and \$38.00 per ton for disposal.

We cannot accept any tires, batteries, concrete, soil, rock, roofing debris, liquid, hazardous, landscape waste or appliances with fre-on compressors still attached. If you wish to include tires for acceptance, contact Lon's Tire Recyclers of Petersburg 217/632-3972. His prices are \$1.00/car tire without rim, \$7.50/semi tire without rim, and \$22.00/tractor tire without rim the prices are to be doubled with rims.

Upon confirmation of award I can commit up to ten – 20yds, three - 25yds, ten – 30yds, one – 40yd, five roll-off trucks, three pup trailers, and two rear load compactor trucks. However, based on 50 loads picked up from the curb last year, I feel that 6 large roll off containers for trash and 1 for appliances should be on the ground during the event with three trucks running to keep them all empty. Since disposal is only available until 12:00 on Saturdays, I feel that the event hours should be limited accordingly.

An Ideal location is West Park, which has a controllable approach, space to be organized, and is away from the public eye. I'm assuming that there will be ten or more people available at the event location. One or two people should be at the entrance to check addresses, inspect loads for unacceptable materials, to hold vehicles back until containers are available, and generally to prevent a free for all. A person should also be at each container to help prevent any backing accidents and to help loading the items. As well as two end loaders to assist with heavy items.

To address verifiable senior citizens and handicapped households that aren't able to get their waste to the event location a rear load compactor truck can be utilized to service these at the curb from a list provided by you, this can be done during the event, or mid week. For compactable items only (nothing steel or strong enough to bend steel) with one driver for \$600.00 per load (add \$25.00/hour for each additional laborer if no Village provided people are available)
