**AN ORDINANCE MAKING SUPPLEMENTAL APPROPRIATIONS  
OF SUMS OF MONEY TO DEFRAY EXPENSES AND LIABILITIES  
OF THE VILLAGE OF CHATHAM FOR THE FISCAL YEAR  
ENDING APRIL 30, 2004**

WHEREAS, on 12-16, 2003, the President and Board of Trustees of the Village of Chatham adopted Ordinance No. 03- 81, the annual appropriation ordinance, for the fiscal year beginning May 1, 2003 and ending April 30, 2004;

WHEREAS, pursuant to Section 8-2-7 of the Illinois Municipal Code, the corporate authorities may at any time by a vote of two-thirds adopt a supplemental appropriation ordinance appropriating funds, the receipt of which were not anticipated at the time the balances available when the annual appropriation was adopted; and pursuant to Section 8-2-7, the provisions applicable to an initial appropriation ordinance relating to publication, notice and public hearing are not applicable;

WHEREAS, since passing the appropriation ordinance, the Village of Chatham has received the unanticipated sum of \$5,674.30 as a refund for telephone service overpayments, and wishes to appropriate such funds for expenditure in the current fiscal year;

*NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:*

**SECTION 1:** In addition to the amounts appropriated pursuant to Ordinance No. 03-81, there are hereby supplementally appropriated the following amounts, for the purposes indicated:


