**AN ORDINANCE APPROVING AN EQUIPMENT LEASE WITH UNITED COMMUNITY BANK**


*BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:*

**SECTION 1:** A proposed lease with United Community Bank of Chatham, for of four squad cars at a lease rate of \$70,460 amortized over three years at an interest rate of 2.75%, with an option to purchase the squad cars at the conclusion of the lease for nominal consideration, is hereby approved.


**SECTION 2:** The Village President is hereby authorized to execute the lease agreement, and thereafter, the proper officers and employees of the Village are authorized and directed to carry out the lease according to its terms.

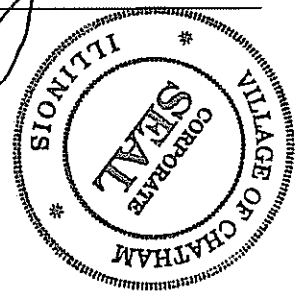



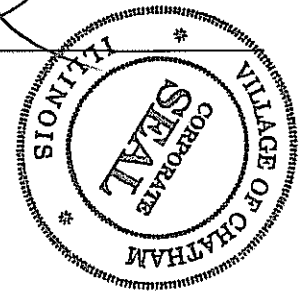
