AN ORDINANCE APPROVING A BID FOR ELECTRIC PLATFORM TRUCK

WHEREAS, the Village of Chatham Electric Department sought and obtained bids for a Truck with a telescopic aerial platform lift; and

WHEREAS, on July 6, 2004 at 1:00 p.m. the bids were opened and the lowest responsible bidder identified per the attached Bid Summary; and

WHEREAS, the Public Works & Utilities Committee met to review the bids and is recommending acceptance of the bid from Altec Industries, Inc. for a 2004 Altec AM55 in the amount of \$107,455.00; minus \$14,000 trade in of our 1992 Altec AA600

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, ILLINOIS, AS FOLLOWS:
