AN ORDINANCE RELATING TO STOP SIGNS ON SPRUCE STREET

WHEREAS, pursuant to Section 11-304 and other sections of the Illinois Vehicle Code, local authorities are required to place and maintain such traffic control devices upon highways under their maintenance jurisdiction as are required in their discretion to indicate and carry out the provisions of the Illinois Vehicular Code; and

WHEREAS, pursuant to Section 11-305 and other sections of the Illinois Vehicular Code, the driver of any vehicle shall obey the instructions of any official traffic control device; and

WHEREAS, Staff have reviewed the appropriate traffic manuals and are not recommending the placement of stop signs on Spruce Street at Winter Park Drive. Spruce Street is a minor arterial while Winter Park Drive is a local street.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: The vehicular intersection of Spruce Street and Winter Park Drive is hereby designated, pursuant to Section 11-304 of the Illinois Vehicular Code, as a location at which stop signs shall placed on Spruce to make the intersection a four way stop.

SECTION 2: This Ordinance shall take effect upon its passage and publication as provided by law. The Clerk shall forthwith publish this Ordinance in pamphlet form and cause the Ordinance to be codified in the Village of Chatham Code of Ordinances..
