AN ORDINANCE ACCEPTING A
BID FOR LEAF COLLECTION

WHEREAS; the Village of Chatham sought and obtained bids for weekly leaf collection in biodegradable paper yard waste bags; and

WHEREAS, the bids included all equipment, labor and disposal cost necessary to provide weekly collection and disposal; and

WHEREAS, on August 20, 2004 at 1:00 p.m. the bids were opened and the lowest responsible bidder identified. The Public Works Committee met to review said bids and is recommending the lowest bid from Capitol Waste Systems for \$15,500.00.

NOW THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Chatham, Sangamon County, Illinois as follows:

Section 1: That the bid from Capitol Waste Systems is hereby accepted.

Section 2: That the appropriate officials be and are hereby directed to sign the necessary forms.

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as provided by law.
