


BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE
OF CHATHAM, ILLINOIS, AS FOLLOWS:

SECTION 1: That the Regular Village Board Meetings of the Village of Chatham for Calendar

Street, Chatham, Illinois on the second (2nd) and fourth (4th) Tuesday of every month, except in
