

ORDINANCE NO. 05-60

AN ORDINANCE APPROVING AN EMPLOYEE
WELLNESS PROGRAM AND EQUIPMENT

WHEREAS, cardiovascular disease is taking an overwhelming toll on society and over one million Americans die each year. Numerous studies and interventions have shown that many risk factors can be prevented or modified through health promotion interventions within the worksite; and

WHEREAS, worksite wellness programs can reduce employee health care costs, improve employee health, enhance productivity and morale; and

WHEREAS, the Administration Committee is recommending a facility be constructed and a program be developed which invests a very modest amount of resources in our employees.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, ILLINOIS, AS FOLLOWS:

SECTION 1: That the expenses are hereby approved.

- A. The quote from crown International Steel Building System, Inc for \$6,890.
- B. Various constructions materials such as concrete, heating & cooling supplies, and flooring at a price not to exceed \$10,000.
- C. Equipment quoted through Fitness for All, Inc. at a price not to exceed \$11,000.
- D. Part-time position of Human Resources Benefits Coordinator at a cost not to exceed \$450.0 per month.
- E. Program services such as health screenings and planning at a cost not to exceed \$2,500.00 annually.
