AN ORDINANCE ACCEPTING QUALIFICATION FOR ELECTRICAL ENGINEERING SERVICES

WHEREAS, the Village sought and obtained Qualifications to provide electrical engineering services and design on a new distribution substation to be located adjacent to Illinois Route 4 in Foxx Creek Subdivision ; and

WHEREAS, the Public Works Committee met on January 10, 2006 to review the qualifications and is recommending the firm of PCI Management & Consulting Company be retained.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, ILLINOIS, AS FOLLOWS:

SECTION 1: That PCI Management & Consulting Company be retained to provide the necessary services to accomplish the task of designing and constructing a distribution substation at the location described above is hereby approved.

SECTION 2: The proper Village Officials are hereby directed to complete the necessary documents at the appropriate timing.

SECTION 3: This Ordinance is effective upon its passage and approval.
