SECTION 1: That the bid from CDS Office Technologies for \$11,872.00 is hereby approved.

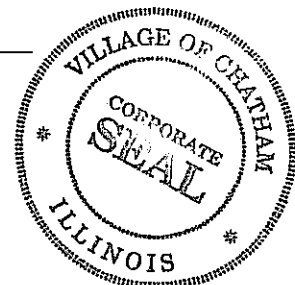
SECTION 2: The staff is hereby directed to complete the necessary documents at the appropriate timing.
