ORDINANCE 08-04

AN ORDINANCE IMPLEMENTING A DRUG AND ALCOHOL
POLICY FOR THE VILLAGE OF CHATHAM

WHEREAS, the Administrative Committee has reviewed the Drug and Alcohol Free Policy and the Drug and Alcohol Free Workplace Policy and has determined the interest of the Village will best be served by implementing the respective policies to comply with current Federal and State regulations.

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: The Drug and Alcohol Free Policy attached hereto shall apply to all Village of Chatham employees whom are required to hold a valid Commercial Drivers License and shall become effective (60)sixty days after the passage of this Ordinance.

SECTION 2: The Drug and Alcohol Free Workplace Police/Dispatch Policy attached hereto shall apply to all Police Officers and Dispatch employees of the Village of Chatham and shall become effective (60) days after the passage of this Ordinance.

SECTION 3: The Drug and Alcohol Free Workplace Policy attached hereto shall apply to all full-time or permanent part-time employees of the Village of Chatham, except those employees described in Section 1 or 2 above and shall become effective (60) days after the passage of this Ordinance.

SECTION 4: This Ordinance effective upon passage and approval, as provided by law. The Clerk shall see to its inclusion in the next published update of the Village of Chatham Code Of Ordinances.
