ORDINANCE 09 - 64

AN ORDINANCE IN REFERENCE TO PAICE EMPLOYMENT

WHEREAS, the Utility Department posted the position of Utility Collections Specialist on the department bulletin board and advertised the position in the Chatham Clarion; and

WHEREAS, the Human Resource Coordinator and the Utility Administration Manager conducted an extensive series of interviews of potential candidates and prepared recommendations for the Administrative Committee.

WHEREAS, on November 3, 2009 a recommendation was presented to the Administration Committee who is recommending the appointment of J. Lynn Paice as the preferred candidate.

BE IT ORDAINED, by the President and Board of Trustees of the Village of Chatham, Sangamon County, Illinois, as follows:

SECTION 1: J. Lynn Paice shall be employed in the Utility Department as the Utility Collections Specialist on a full time basis paid per the current union contract. The distribution shall be 30% from the General Fund, 35% from the Electric Fund and 35% Water Fund. Per the current contract employees shall serve 120 day probationary period.

SECTION 2: This Ordinance shall be in full force and effect upon passage and approval.
