AN ORDINANCE AMENDING APPENDIX B TO CHAPTER 150 OF THE VILLAGE OF CHATHAM CODE OF ORDINANCES PERTAINING TO BUILDING INSPECTION FEES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: Subsection A of Appendix B to Chapter 150 of the Code of Ordinances of the Village of Chatham is amended to state as follows (amended language ~~struck out~~, new language underlined):

(A) Building permit fee. ~~\$.12~~ \$.15 per square foot, or ~~\$40.00~~ \$70.00, whichever is greater.

SECTION 2: This ordinance is effective upon its passage, approval and publication as required by law. The Clerk shall publish this ordinance in pamphlet form and see to its inclusion in the next update of the Village of Chatham Code of Ordinances.


