AN ORDINANCE PERTAINING TO THE YARD WASTE SERVICE CHARGES, AND AMENDING THE VILLAGE OF CHATHAM CODE OF ORDINANCES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: Section 53.49 of the Chatham Code of Ordinances, pertaining to the yard waste service charge, is amended to state as follows (new language underlined, deleted language ~~stricken through~~):

§ 53.49 ~~YARD WASTE~~ GREEN PROGRAM SERVICE CHARGE.

Each utility customer in the village shall be assessed a monthly service charge increased from \$1.00 to \$2.00 for each month of the year to defray the cost of collection and disposal of yard waste pursuant to § 53.48, authorized tree waste pursuant to Section 53.70 through 53.74, the Annual Village Clean-up Program and other recycling/clean-up projects of the Village. The service charge shall be charged and collected along with the monthly utility bill to each customer. The service charges shall be placed in a special fund in the village treasury and used only to defray the cost of the above described services in § 53.47, ~~together with other costs of operation and maintenance of the leaf collection program, the tree waste and burn pile program, the annual village cleanup, and other green/recycling projects as directed from time to time by the corporate authorities.~~

SECTION 3: This Ordinance is effective on its passage and publication as required by law. The clerk shall publish this Ordinance in pamphlet form. The Clerk shall see to inclusion of this Ordinance to the Village Code of Ordinances in the next update thereof.


