AN ORDINANCE IN REFERENCE TO CRAWFORD EMPLOYMENT

WHEREAS, the Administrative Department posted the position of Code Enforcement Officer on the department bulletin board and;

WHEREAS, the Human Resource Coordinator, the Public Works Manager, and a consultant from Human Resources Inc. conducted an extensive series of interviews and examinations of potential candidates and prepared recommendations for the Administrative Committee.

WHEREAS, on August 7, 2012 a recommendation was presented to the Administration Committee who is recommending the appointment of Ryan Crawford as the preferred candidate.

BE IT ORDAINED, by the President and Board of Trustees of the Village of Chatham, Sangamon County, Illinois, as follows:

Ryan Crawford shall be employed in the SECTION Administrative Department as the Code Enforcement Officer on a full time basis paid \$2076.92 biweekly. The distribution shall be 100% from the General Fund. Per the Village of Chatham Personnel Code employees shall serve 120 day probationary period.

SECTION 2: This Ordinance shall be in full force and effect upon passage and approval.
