**AN ORDINANCE AMENDING THE NUMBER OF LIQUOR LICENSES TO BE ISSUED BY THE VILLAGE OF CHATHAM AND AMENDING THE VILLAGE OF CHATHAM CODE OF ORDINANCES**


*BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHATHAM, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS.*

**SECTION 1:** Section 111.17(I) of the Code of Ordinances of the Village of Chatham is amended to state as follows:

(I) The number of licenses issued by the Village shall be as follows:

- (1) There may be one Class B licenses;
- (2) There may be five Class C licenses;
- (3) There may be one Class G license;
- (4) There may be two Class N license;
- (5) There may be two Class P licenses;
- (6) There may be one Class LP licenses;
- (7) There may be two Class R-1 license;
- (8) There may be four Class R-2 licenses;
- (9) There may be one Class SE license outstanding at any time;
- (10) There may be three Class T licenses.

**SECTION 2:** This Ordinance is effective upon its passage and approval. The Clerk shall see to its inclusion in the next published update of the Village Code of Ordinances.
